Instructor: Jerry Hastings, ASLA. Jerry has over 40 years of experience as a licensed landscape architect

working in both the public and private sectors. Jerry has taught various license prep courses since 1984, and has over 30 years experience teaching a variety of landscape architectural

courses, primarily at the University of California at Los Angeles.

In 2004, Jerry decided to focus exclusively on preparing licensure candidates to sit for LARE Section E, Grading, Drainage and Stormwater Management, which he also currently teaches at UCLA as well as independently in other cities in the western United States. Jerry is also the author of *LARE Review Section E Vignettes: Grading, Drainage, and Stormwater Management* published by Professional Publication, Incorporated (PPI). About the LARE Section E Workshop at Arizona State University

The LARE Section E Workshop is designed to improve your probability of passing Section E, Grading, Drainage and Stormwater Management. It does so by focusing on the two key proficiencies you need to pass.

- 1. **Subject Matter Mastery.** To pass Section E, you must have a thorough technical knowledge of grading, drainage and stormwater management. To address this need, the workshop is structured as a short, *intense* grading and drainage course with a focus on the unique nature of the exam. Exercises, with solutions, are used to reinforce the learning experience (solutions are provided for all exercises and vignettes).
- 2. **Test-taking Experience.** Knowing how to take the test is arguably as important as subject matter mastery! The three essential components of test taking are:

- Familiarity with the form of the exam—the LARE differs from the practice of real world grading design. Any resemblance to the practice of real-world grading and drainage is superficial. The problems are contrived and artificial. Second, the time allotted to complete each vignette (approximately 1-1/4 hours per vignette, or four vignettes in five-hours) is considerably less than would typically be allotted in an office practice environment, yet solutions must be taken to a point well beyond schematic.
- Familiarity with basic vignette types—i.e., topographic/watershed, retention/detention of stormwater, screening with earthen mound, plan and profile, horseshoe swale, etc.—the most effective way to attain adequate test-taking experience and exam type familiarity is through exposure to sample vignettes that closely resemble the actual exam in subject matter, scope and rigor. To provide the most realistic possible exposure, the workshop features more than 35 vignettes that span the gamut of vignette types.
- Stamina. This often-overlooked "personal resource" is essential to success. The examinee must be able to concentrate at the highest level for five-hours straight. Through solving vignettes under conditions that closely replicate actual test taking in terms of time pressure and rigor, workshop attendees are, in effect, participating in an exam dress rehearsal.

What you get: In addition to 23-hours of exam-specific classroom instruction, your enrollment includes an exam-specific textbook containing over 235-pages of instructional materials including exercises (with solutions), and more than thirty-five 11" x 17" practice vignettes (with solutions, of course).

Pre-Workshop Materials:
