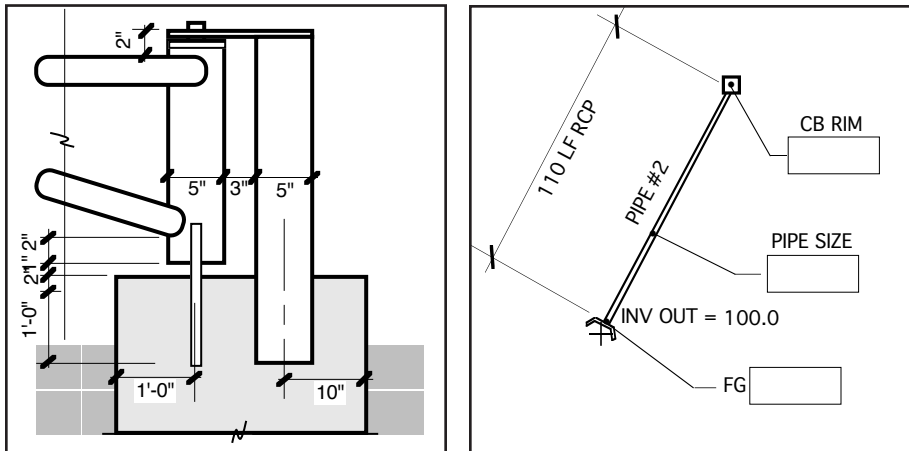

Our Performance Section classes are generally given during the months of April and October. The Multiple Choice Section classes are generally given in January and July.

# An Overview of the LARE and Intensive Review of the Objective Sections

## Sections A, B and D of the LARE Landscape Architects Registration Examination

Through lecture, group discussion, and practice tests, this intensive three day course focuses on preparing students to take the LARE, concentrating on the multiple choice sections of the exam as well as providing a detailed overview of the exam structure. Specific sections of the LARE to be covered include:

Section A: Project and Construction Administration  
Section B: Inventory, Analysis and Program Development  
Section D: Design and Construction Documentation

The course includes an in depth overview of the exam and the fundamentals of the impact of a wide variety of typical issues and challenges which affect the design and construction processes, as well as regulatory and professional practice impacts on Landscape Architecture. Each student will receive a course binder containing over 450 pages of information pertinent to the exam, focusing on sections A, B& D.

- How the exam is scored; Exam preparation strategies and tips
- Project and Construction Administration
- Project Assessment and Review
- Problem Definition
- Inventory and Analysis
- Project Programming
- Development and Evaluation of Alternatives

- Materials and Methods of Construction

Students will be given a grounding in the format, goals and requirements of the LARE. Lectures on a variety of topics tested by the exam and encountered in professional practice will be given over all three days. An extensive list of typical questions specific to each objective section of the exam will be given out and used as mock timed exams of Sections A, B and D. The questions and answers will be then be reviewed as a group exercise led by the instructors.

## *Overview and Sections A, B & D Who Should Attend*

This course would benefit candidates for the LARE who are taking the exam for the first time or are having difficulty with any of the objective sections. Additionally, individuals who would like to further their knowledge of technical and administrative aspects of the topics covered by these sections of the exam could benefit.

Ray Freeman is a principal of Freeman & Jewell Landscape Architecture in Berkeley, CA and has over 30 years of experience as a landscape architect. He is also a Certified Professional Erosion and Sedimentation Control Specialist. He has taught as a lecturer at UC Berkeley, Cal Poly San Luis Obispo, UC Davis Extension, Merritt College and Harvard University.

Jake Tobias is a landscape architect and project manager at Wallace Roberts & Todd in San Francisco, CA and teaches classes at UC Berkeley Extension. He holds an MLA from UC Berkeley.

Classes may be cancelled or rescheduled due to circumstances beyond our control. In the event a class is cancelled, a full refund will be made for that class.

The YMCA Point Bonita Conference Center is located between the Point Bonita Lighthouse and Rodeo Beach and is within the Golden Gate National Recreation Area. Their website is at <http://www.ymcasf.org/ptbonita/> The YMCA facility is within easy walking distance of the Point Bonita Lighthouse, Rodeo Beach and Rodeo Lagoon. Waterfowl and wildlife abound on and adjacent to the campus. The Marin Headlands area offers wonderful views of the coast, San Francisco and the Golden Gate Bridge, hiking, bicycling, camping, and picnicking opportunities.

The principal instructor stays at the YMCA throughout the weekend, acting as host, leading night time hikes, answering LARE questions, and generally trying to make everyone's stay enjoyable.

### **1. Fees**

**The fee for this class is \$445 if your registration is postmarked January 8, 2010 or earlier. After January 10, the registration fee is \$470.**

**Lunch all three days is included in the course fees.**

Complimentary coffee and tea, soft drinks, bottled water and light snacks are provided as part of the course.

### **2. Room and Board Options**

You may sign up to spend the night at the YMCA as part of the course package. You may also sign up for Breakfast and/or Dinner as well. Vegetarian or Vegan options on all meals may be requested. Meals are cafeteria style, all you can eat. The food is generally quite good. The closest commercial eating establishments are in Sausalito, 15 minutes away.

Bunkhouse style accommodations: You will need to bring your own sleeping bag or bedclothes, pillow, washcloth, towels, and toiletries. Flashlights are highly recommended for night time hiking.

#### **The following options are available:**

Option 1: 3 Nights stay with extra meals (Room: Thu, Fri, Sat ...Breakfast Friday thru lunch Sunday) [\$110]

Option 2: 2 Night stay with extra meals (Room: Fri, Sat ...Lunch Friday thru lunch Sunday) [\$80]

Option 3: Room Fri and Sat only, no extra meals. [\$40]

Linen: Pillows, sheets, blankets, washcloths and towels provided by the YMCA for your stay. [\$30]

All of the above prices include sales tax.

**Extra nights are \$30/person/night. Extra meals are \$11 each.**

For example, you can stay at the Y on the Sunday night after class if requested in advance. Dinner Thursday night may be arranged. Again, check with us in advance.

**Due to planning requirements of the YMCA, you must sign up for the room and board options at the same time you register for classes.**
